#### **ABOUT THE CONFERENCE**

The vast changes that are happening in the world of international relations are of great relevance to the study of Public Affairs and Governance. The epoch-making event of the Covid-19 pandemic is said to have created some fundamental changes in our lives and in our world. The pandemic has strengthened nation-states and has strengthened national borders. Free movement of people – a dream of the liberal international mission that dominated international politics for several decades – has been curtailed. In the West, debates rage about the limits to freedom placed by a suddenly coercive state. In the global South, many states have utilized the pandemic to impose further authoritarian regulations stifling social and protest movements. The harsh and sudden lockdowns imposed by states also resulted in catastrophic consequences particularly for the poor – exemplified by the migrant labour crisis in India in 2020.

Apart from the pandemic, various geopolitical events, especially the astonishing takeover of Afghanistan by the Taliban, make us ask several questions on how the post-pandemic world would look like and what would it mean for the people of the world and the idea of human rights. What would the closing of borders mean for the free movement of people? How do the recent geopolitical fallouts and the refugee crises they created to impact the rights of refugees? How do these factors help in the othering of 'outsiders' as distinct from 'citizens'? Whether the West-led liberal international order and its international institutions still hold relevance or are we witnessing a new world order with a retreating West and a resurgent China and many 'illiberal' authoritarian states that are inspired by its model of governance? These are some of the questions that the debates on global governance and global public policy have to occupy themselves with, in our current times.

This conference would attempt to address, debate, criticize and reflect on these newly emerging complex problems of our times under three sub-themes – the contested politics of migration and citizenship, the recent rise of authoritarianism and restrictions of rights, and the politics of the environment, climate change, and post-human rights.
